

**“LA CUCINA DI REGINA” SWEEPSTAKES - OFFICIAL RULES
NO PURCHASE NECESSARY TO ENTER OR WIN**

1. HOW TO ENTER: Sweepstakes begins 12:01 AM (ET) 4/3/05 and ends 11:59 PM (ET) 10/11/05 ("Entry Period"). There are three (3) ways to enter: 1) complete the official entry form and mail to the designated P.O. Box specified on the form; 2) online at www.reginavinegar.com, follow the links, fully complete the online entry form and click to submit or 3) hand print your name, complete mailing address, zip code, and telephone number on a 3" x 5" piece of paper and mail in a stamped envelope to: “LA CUCINA DI REGINA” SWEEPSTAKES, P.O.
